Selected customers eligible for the campaign, will receive an APN (App Push Notification) message on the FNB App or RMB Private Bank App and/or an E-mail advising them of the Campaign.2. The message will detail the metrics of the campaign, which customer must use their FNB or RMB Private Bank Global Account Virtual or Physical Card (any of the supported spend currencies i.e. Euro, Pound, Dollar), Virtual Credit Card, or a combination of both when spending internationally.3. The customer will be notified in the message, the period to complete the action as per number 2 above.4. The aforesaid customers must have all (100%) of their international card spend done on their Global Account Virtual or Physical Card, Virtual Credit Card or a when spending internationally.5. A minimum spend of R1000 (One Thousand Rand only) or currency equivalent is required.6. Eligibility: Who qualifies to take part?	<ul style="list-style-type: none"> Existing FNB or RMB Private Bank Global Account or Credit Card Holding customers who receive the App push text and/or email will be eligible to participate; The selected customers have either previously done international spend using any of their FNB/RMBPB accounts, or have shown intent to travel internationally (e.g. Purchased international flights); The selected customer is eligible for a virtual card or already have created a virtual card for the above qualifying accounts; You are a natural person over the age of 18; You are in possession of a valid South African ID book or valid passport for identification purposes; You have an active eBucks account; Your account/s is active or in good standing. This means that none of your FNB and FirstRand Bank accounts and credit agreements should be overdrawn, or be in arrears, or be in default, or be subject to any legal process with FNB or FirstRand Bank. IMPORTANT
