



**FNB Virtual Card Subscriptions Campaign  
CAMPAIGN RULES**

Read these Campaign rules carefully. These Campaign rules ("rules") explain your rights and duties in connection with this Campaign. If you take part in this Campaign and/or accept any reward, these rules will apply to you, and you agree that the promoter(s) can assume that you have read and agreed to be legally bound these Campaign rules.

<b>Campaign Name:</b>	<b>FNB Virtual Card Subscriptions Campaign</b>
<b>Promoter(s) Name(s):</b>	<p>This Campaign is run by FNB a division of FirstRand Bank Limited with Reg. No. 1929/001225/06 having its principal place of business at 1 First Place, Bank City, cnr Simmonds and Pritchard Streets, Johannesburg.</p> <p>In these rules reference to "promoter(s)" or "the promoter(s)" or "us" or "we" means FRB.</p> <p>Reference to "participants" means "you" and subject to the terms, conditions and the rules as set out below.</p>
<b>The Campaign Offers:</b>	<ol style="list-style-type: none"><li>1. Selected customers in the campaign will receive an APN (App Push Notification) message on the FNB App.</li><li>2. The selected customers must move the listed subscriptions (a subscription is an arrangement to receive something, typically a publication or online service, regularly by paying in advance) in the APN from their physical card to their virtual card within two weeks (calendar days) from the campaign start date in order to qualify for a once-off cash back reward.</li><li>3. Customers who qualify will be rewarded as follows:<ol style="list-style-type: none"><li>a. If customers move <b>three or less</b> of their subscriptions to their virtual card, they will be rewarded with <b>R100</b> cash back into their account.</li><li>b. If customers move <b>four or more</b> of their subscriptions to their virtual card, they will be rewarded with <b>R200</b> cash back into their account.</li></ol></li><li>4. Customers who qualify receive their cash back into the FNB account that is linked to the virtual card that was used.</li><li>5. Limited to one cash back per customer only.</li><li>6. The cash back is limited to the first 3 000 customers.</li></ol>



	7. Cash back will be paid into the account within 7 business days from when the customer has performed the action as per number 3 above.

<b>Eligibility: Who qualifies to take part?</b>	<ul style="list-style-type: none"> <li>Existing FNB Credit Card, FNB Fusion and FNB Debit card customers who receive the FNB App push notification, and move their subscriptions from their physical card to their virtual card will be eligible to participate;</li> <li>Natural person over the age of 18;</li> <li>Customers in possession of their valid South African ID book/Smart Card or valid passport for identification purposes;</li> <li>Customers whose account/s is in good standing. This means that none of their FNB and FirstRand Bank accounts and credit agreements should be overdrawn, or be in arrears, or be in default, or be subject to any legal process with FNB or FirstRand Bank. Legal process means any legal proceedings in any court of law involving you and FNB or FirstRand Bank, including but not limited to: business rescue, collections, liquidation, administration and sequestration proceedings. Legal process excludes debt review as provided for in s86 of the National Credit Act (No. 34 of 2005); and</li> <li>Customers who are not excluded in the categories of people listed below who cannot take part. We will treat your information in total confidence and will not sell, share or rent this information to any other third parties.
