	In these rules we refer to the above promoter(s) as "the promoter(s)" or "FNB". We refer to participants and winners as "you".
Entries open and close:	Entries open on <25 September 2023> at <00h01>.
	Entries close on <25 February 2024 > at <23h59>.
	All entries, fully completed as required, must be received by the promoter(s) by the 25th day of each month during the competition period.
	There will be 200 winners every month for the duration of the competition period.
	The promoter(s) reserve the right to end or extend the competition. Notice of this will be posted in these rules.
Eligibility: Who qualifies to take part?	<ul> <li>a. Existing FNB customers with a South African 13-digit ID number who hold either an FNB Easy Zero, Easy Pay-As-You-Use (PAYU), Easy Smart, Aspire Account, Aspire Fusion Account or Aspire Encore Account, who are over the age of 18 and who reside in South Africa.</li> <li>b. Existing FNB customers who hold an FNB Easy Zero, Easy Pay-As-You-Use (PAYU), Easy Smart, Aspire Account, Aspire Fusion Account or Aspire Encore Account, that have not made use of the eWallet send functionality on the FNB App for the previous 3 months, prior to the competition launch.</li> <li>c. The qualifying account must be in an active status and in *good standing with the Bank.</li> <li>d. The qualifying customer must be registered on the FNB Banking App.</li> <li>e. The qualifying customer must send one or more eWallets on the FNB Banking App per month.</li> <li>f. How to enter?	Existing FNB customers who hold an FNB Easy Zero, Easy Pay-As-You-Use (PAYU), Easy Smart, Aspire Account, Aspire Fusion Account or Aspire Encore Account, that have not made use of the eWallet send functionality for the previous 3 months on the FNB App, prior to the competition launch, will receive communication from FNB (FNB App notification) notifying the qualifying customer to encourage them on sending an eWallet via the FNB Banking App and they will stand a chance to win in the draw should they send an eWallet. 1 eWallet send would equal to 1 entry into the draw.  The more eWallet sends a customer makes on the FNB Banking App, the better their chances of winning a R500 (five hundred rand) Checkers Voucher.
Is there a limit on the number of times you can enter?	No, each eWallet send on the FNB Banking App made by the qualifying customer equals to an entry into the competition.
How will winner(s) names be announced?	Winners will not be announced.
	A random draw will take place at the beginning of every new month and the winners of this competition will be notified. Winners will be notified via SMS or via the FNB App or a combination of both on the cellphone number indicated on the customers banking profile. Vouchers will be distributed via SMS to the winners.
	There will be 200 winners every month (for a period of 5 months) who will each win a R500 (five hundred rand) Checkers voucher.
Deadline for claiming prize(s)	The voucher must be redeemed within 6 months after it has been issued. The full voucher amount of R500 must be used at once, as no change will be given and the amount left cannot be carried over on the voucher.

## Tax implications for prize(s)
